# The project

Global Correspondent Banking 1870-2000 <a href="https://glocobank.web.ox.ac.uk/home">https://glocobank.web.ox.ac.uk/home</a> is a major 5-year research project (2021-2025) funded by the European Research Council Advanced Grant scheme and led by Professor Catherine R. Schenk at the University of Oxford. The overall objective is to analyse the changing shape of international banking networks across the 20th century using an innovative methodology that allows greater specificity and inclusion than ever before. The bilateral correspondent banking network that will be uncovered by GloCoBank was the structure on which the global financial system was built and on which the trade and specialization that drove global development was based,













but we know very little about it. GloCoBank will create and analyse a new set of data and combine it with extensive archival research, which will allow a much more granular assessment of the patterns and dynamics of international banking and payments. The data will capture the links between thousands of individual banks involved in international payments through bilateral correspondent banking contracts across 130 years.

#### The role

Reporting to the Principal Investigator, Professor Catherine Schenk, the post holder will be a member of a research group for an ERC-funded project on international bank networks in the 20<sup>th</sup> Century (GloCoBank). They will be attached to a research stream that will use archival research and advanced statistical analysis to analyse the dynamics of correspondent banking relationships in Europe during this period, including the banks' strategy and the impact of economic and political shocks. They will work alongside a cohort of up to five Post-Doctoral researchers and have the opportunity to present and publish their research findings and take a full part in the scholarly community at University of Oxford.

# Responsibilities

- Manage own academic research and administrative activities. This involves small scale project management, to co-ordinate multiple aspects of work to meet deadlines
- Adapt existing and develop new research methodologies and materials
- Prepare working theories and analyse qualitative and/or quantitative data from a variety of sources, reviewing and refining theories as appropriate
- Maintain good communication with the project administrator, report regularly to the Principal Investigator and contribute to the reporting requirements for the project funder.
- Develop ideas for generating research income, and present detailed research proposals to senior researchers
- Collaborate in the preparation of research publications, and book chapters with other members of the project team

- Carry out collaborative projects with colleagues in partner institutions, and research groups
- Undertake other duties related to the project as required by the Principal Investigator.

### Selection criteria

#### Essential selection criteria

- Hold a relevant PhD/DPhil, or evidence that a doctorate is close to completion, together with relevant experience
- Possess sufficient specialist knowledge in the discipline to work within established research programmes: this may include expertise in financial history or another cognate discipline and knowledge of European economic history from 1870-2000
- Experience in managing data through spreadsheets and databases and applying statistical methods to data
- Experience in archival research and collection of quantitative data
- Fluency in reading more than one European language and willingness to travel to archives in Europe where appropriate.
- Ability to manage own academic research and associated activities and meet deadlines
- Previous experience of contributing to publications/presentations
- Ability to contribute ideas for new research projects and research income generation
- Excellent communication skills, including the ability to write for publication, present research proposals and results, and represent the research group at meetings

#### Desirable selection criteria

- Demonstrable experience in statistical methods, (e.g. R, Stata, GIS)
- Expertise in programming and geographic/networking software as applied to large databases.
- Willingness to undertake additional training in research methods as required.
- Experience of independently managing a discrete area of a research project
- Experience of actively collaborating in the development of research articles for publication
