The role

This is an exciting opportunity to join the thriving Modern Asian History community in the History Faculty, and to develop teaching experience at the undergraduate and graduate levels. You will be associated with the History Faculty and you will also be an associate of the University's China Centre. Although this is primarily a teaching role, you will also conduct independent research, and play an active part in the University's interdisciplinary community.

You will have research and teaching interests in any area of Modern Chinese History or East Asian History with a focus on China. You will demonstrate an ability and willingness to teach and supervise across a range of topics in Chinese and East Asian History during the late nineteenth and twentieth



centuries, and you must also be able to contribute as appropriate to the teaching of wider options in Global History.

You will be able to inspire and enthuse students and draw on your own research to inform and augment your teaching.

This post does not currently carry a college association; however, the Faculty will support the post holder, where possible, to identify opportunities to secure a college association.

Responsibilities

Teaching, supervision and course administration

5. Set and mark internal examinations ('collections');

6. Be the first point of contact for students as required in matters relating to attendance, conduct, coursework, performance, and welfare (referring matters to appropriate others as needed);
7. Ensure that students have a high-quality academic experience and appropriate levels of support;
8. Participate in student admissions and outreach activity, including open days and access events, for the Faculty. The undergraduate admissions exercise in History also includes marking History Aptitude Test scripts, and conducting admissions interviews which are held after the end of the first term of the academic year.
9. Share in the organisational responsibility and academic administration for undergraduate degrees in History.
10. Gather and analyse feedback from students, colleagues, and examiners, and modify course design, content, or delivery as appropriate.

11. In support of the development of courses and teaching, manage your own academic research activities and conduct independent research;
12. Write innovative research-based publications, including articles for peer-reviewed journals, and disseminate research findings at conferences.
13. Participate in seminars, workshops and conferences as appropriate in the Faculty of History and in the China Centre.

General duties

14. Engage positively and proactively with the academic community in the Faculty and College.
15. Participate in the activities of the Oxford China Centre, and the Oxford Centre for Global History.

Essential	A completed doctorate in a relevant field, or evidence that a doctorate is close to completion, e.g., candidates who have submitted their dissertation will be considered, subject to successful examination.
Teaching and research	
Essential	An aptitude for teaching, the ability to inspire and enthuse students of high ability, and some experience of teaching Chinese and East Asian History.
Essential	Sufficient depth and breadth of knowledge in Chinese and East Asian History to develop course materials.
Essential	The ability to take on administrative responsibilities relating to undergraduate teaching and student progression.
Essential	A strong publication record commensurate with career stage, a clear profile of the research to be undertaken during the period of appointment, and familiarity with the existing literature and research in the field of Chinese and East Asian History.
Personal effectiveness	
Essential	Outstanding communication and interpersonal skills.
Essential	Professionalism as a colleague and a proven track record of working effectively with others.
Technical skills	
Essential	Computer literacy and ICT competence, including the ability to engage with bespoke University and College software.

The Faculty of History

The Faculty of History in Oxford is the largest in the United Kingdom and one of the largest in the world. It has a very strong international reputation for its scholarship and its teaching of undergraduate and graduate students, with particular strengths in the history of the British Isles, continental Europe, imperial and global history, the United States, economic and social history, intellectual history and the history of science, medicine and technology. Within the Faculty there is also a department for the History of Art and a number of dedicated research centres.

The Faculty of History provides a robust and supportive framework for research, including:

- Financial support for research travel, research assistance, and editorial help
- Mentoring, including discussion of research plans and progress
- Internal and interdisciplinary collaborations, through research centres
