The role

This is an exciting opportunity to join the thriving Economic and Social History community in the History Faculty, and to develop experience in teaching and course administration at the graduate level. You will be associated with the History Faculty and you will also be an associate of the <u>Oxford Centre for</u> <u>Economic and Social History</u>. Although this is primarily a teaching and organizational role, you will also conduct independent research, and play an active part in the University's interdisciplinary community.

You will have research and teaching interests in any area of Economic and Social History. You will demonstrate an ability and willingness to teach and supervise across a range of topics in Economic and Social History, with no specification as to historical period or region of the world.



You will be able to inspire and enthuse students and draw on your own research to inform and augment your teaching.

This post does not currently carry a college association; however, the Faculty will support the post holder, where possible, to identify opportunities to secure a college association.

Responsibilities

Teaching, supervision and course administration

- 1. Provide lectures and classes for the papers listed below:
 - At least one Graduate Course: Advanced Option Paper in Economic and Social History (to complement <u>existing options</u>);
 - Contribute a lecture/seminar to Graduate Course: <u>'What Happened and Why: An</u> <u>Introduction to Themes and Approaches in Economic and Social History'</u> (taught jointly with senior postholders);
 - Contribute 2 lectures to Undergraduate Courses in the Faculty of History (Capitalism and Empire; Evolution of the Global Economy)
 - Contribute to <u>'Quantification in History'</u> for the BA in History/History and Politics;
 - Other teaching as required.
- 2. Lecture, tutor, and supervise undergraduate and postgraduate students, including cosupervision of MSc and MPhil theses in Economic and Social History;
- 3. Take part in University examining in Economic and Social History as and when requested to do so for the Faculty;
- 4. Contribute to admissions:
 - to the undergraduate programme in History and Economics; and
 - to the MSc, MPhil, and DPhil in Economic and Social History (under the guidance of senior postholders in Economic and Social History).
- 5. Represent the Economic and Social History Group in relevant Faculty Committees;
- 6. Ensure that students receive timely feedback on their work during term, both week by week and in termly reports;
- 7. Contribute to the organization of seminars, workshops and guest lectures in Economic and Social History
- 8. Gather and analyse feedback from students, colleagues, and examiners, and modify course design, content, or delivery as appropriate

Research

- 9. In support of the development of courses and as a secondary commitment alongside teaching, manage own academic research activities, conduct independent research, and generate original ideas to build on existing concepts
- 10. Write innovative research-based publications, including articles for peer-reviewed journals, and disseminate research findings at conferences.
- 11. Participate in seminars, workshops, conferences, and invited lectures as appropriate in the Faculty of History and in the Oxford Centre for Economic and Social History.

General duties

- 1. Be first contact for student matters relating to attendance, conduct, coursework, performance, and welfare (referring matters to appropriate others) and help to ensure that students have a high-quality academic experience;
- 2. Engage positively and proactively with the academic community in the Faculty of History and the Department of Economics.
- 3. Participate in the activities of the Oxford Centre for Economic and Social History.

Essential	A completed doctorate in economic and/or social history, or evidence that a doctorate is close to completion, e.g., candidates who have submitted their dissertation will be considered, subject to successful examination.

Essential	An aptitude for teaching, the ability to inspire and enthuse students of high ability, and some experience of teaching Economic and Social History.
Essential	Sufficient depth and breadth of knowledge in Economic and Social History to develop course materials.
Essential	The ability to take on administrative responsibilities relating to teaching and student progression.
Essential	A strong publication record commensurate with career stage, a clear profile of the research to be undertaken during the period of appointment, and familiarity with the existing literature and research in the field of Economic and Social History.
Desirable	Experience of pastoral care of students.
Personal effectiveness	
Essential	Outstanding communication and interpersonal skills.
Essential	Professionalism as a colleague and a proven track record of working effectively with others.
Technical skills	
Essential	Computer literacy and ICT competence, including the ability to engage with bespoke University and College software.

The Faculty of History

The Faculty of History in Oxford is the largest in the United Kingdom and one of the largest in the world. It has a very strong international reputation for its scholarship and its teaching of undergraduate and graduate students, with particular strengths in the history of the British Isles, continental Europe, imperial and global history, the United States, economic and social history, intellectual history and the history of science, medicine and technology. Within the Faculty there is also a department for the History of Art and a number of dedicated research centres.

The Faculty of History provides a robust and supportive framework for research, including:

- Financial support for research travel, research assistance, and editorial help
- Mentoring, including discussion of research plans and progress
- Internal and interdisciplinary collaborations, through research centres

• Assistance in the formulation of research plans and funding bids

The Faculty enables all its postholders, including departmental lecturers, to request up to £800 per year for research expenses, and makes additional funds available for organising conferences in Oxford. In addition, to assist newly-appointed postholders in the development and publication of their research, Faculty funds are available for early career and established colleagues to hold a workshop at which colleagues can discuss drafts of their next monograph.

The Faculty is located in the Old Boys' High School, George Street.
