## The Project

Global Correspondent Banking 1870-2000 is a major 5-year research project (2021-2026) funded by the European Research Council Advanced Grant scheme and led by Professor Catherine R. Schenk at the University of Oxford. The overall objective is to analyse the changing shape of international banking networks across the 20th century using an innovative methodology that allows greater specificity and inclusion than ever before. The bilateral correspondent banking network that will be uncovered by GloCoBank was the structure on which the global financial system was built and on which the trade and specialization that drove global development was based, but we know very little about it. GloCoBank will create and analyse a new set of data and combine it with extensive archival research, which will allow a much more granular assessment of the patterns and dynamics of international banking and payments. The data will capture the links between thousands of individual banks involved in international payments through bilateral correspondent banking contracts across 130 years.



## The Role

Reporting to the Principal Investigator, Professor Catherine Schenk, the post holders will be a member of a research group for an ERC-funded project on international bank networks in the 20<sup>th</sup> Century (GloCoBank) [<https://glocobank.web.ox.ac.uk>]. They will be attached to a research stream that will carry out data analysis related to the correspondent banking relationships of international banks from 1870-2000. They will use advanced statistical analysis and relevant software to prepare the data, explore causation/correlation with relevant variables and develop visualisation and network analysis of the many thousands of correspondent banking links recorded in published sources during this period. They will work alongside a cohort of three to five Post-Doctoral researchers and have the opportunity to present and publish their research findings and take a full part in the scholarly community at the University of Oxford.

## Responsibilities

- Demonstrable experience and expertise in advanced statistical methods, programming and geographic/networking software as applied to large datasets (including R, Stata, GIS, network analysis);

- Previous experience of contributing to publications/presentations;
- Ability to contribute ideas for new research projects and research income generation; and
- Excellent communication skills, including the ability to write for publication, present research proposals and results, and represent the research group at meetings.

### **Desirable selection criteria**

- Experience of independently managing a discrete area of a research project;
- Experience of actively collaborating in the development of research articles for publication; and
- Willingness to undertake additional training in research methods as required.
