The role

The Faculty of History is the largest faculty in the Humanities Division and one of the largest teaching departments in the University. The Faculty has close to 200 staff including over 100 academic postholders and over 1,500 registered students.

The Taught Postgraduate Degrees Officer is responsible for the management of the Faculty's 250 PGT students progression processes, including examination administration, across 6 taught postgraduate courses. The role provides expert advice and administration on matters related to PGT courses and students including support to the Academic Administration Manager, Education Manager and Director of Graduate Studies.



Responsibilities

- Respond to general and complex enquiries from prospective and current students and from colleagues, interpreting university and external regulations as appropriate and making decisions regarding interpretation without referring to others;
- Manage the post-graduate taught progression process (e.g., optional paper ballot, submissions, examination results) taking responsibility for liaising with students, supervisors, Board Interviewers, and the Director of Graduate Studies and recording information on local systems and the University central system;
- Work with the Research Degrees Officer to collate and distribute marks and feedback to students for taught post-graduate summative assessments, keep records of marks on local and University systems;
- In liaison with Chairs of Exam Boards propose the allocation of markers for all summative assessments;
- Service the annual Designated Studentships meeting;
- Regularly review and implement necessary updates to post-graduate taught pages on the History Faculty website, Oxford Historians Hub, Canvas and Sharepoint;
- Run annual student feedback surveys for all post-graduate taught programmes;
- Develop and maintain administrative procedures i.e. The completion of the annual Assessment Review; updating examination conventions, mark schemes, student handbooks and any other materials relating to post-graduate taught programmes;
- Regularly review and implement necessary updates to post-graduate taught pages on the History Faculty website, Oxford Historians Hub, Canvas and Sharepoint;

Examinations

- Work alongside the Chairs of Exam Boards in the effective servicing of Masters Boards including the production of meeting reports and provide any necessary guidance in the reviewing of mitigating circumstances applications;
- Responsible for checking and sharing ratified marks with the Academic Record Office prior to release on evision;
- Responsible for nominating Exam Boards, Examiners (internal and external) to the University's Examiner Appointment and Payments (EAP) system and ensuring their approval by the Senior Nominating Officer.

Other

- Any other duties commensurate with the grading of the post;
- Supporting key academic cycle processes (for example examinations and admissions) as and when required to do so.

Selection criteria

The Faculty of History

The Faculty of History in Oxford is the largest in the United Kingdom and one of the largest in the world. It has a very strong international reputation for its scholarship and its teaching of undergraduate and graduate students, with particular strengths in the history of the British Isles, continental Europe, imperial and global history, the United States, economic and social history, intellectual history and the history of science, medicine and technology. Within the Faculty there is also a department for the History of Art and a number of dedicated research centres.

The Faculty of History provides a robust and supportive framework for research, including:

- Financial support for research travel, research assistance, and editorial help

- Internal and interdisciplinary collaborations, through research centres

The Faculty enables all its postholders, including departmental lecturers, to request up to £800 per year for research expenses, and makes additional funds available for organising conferences in Oxford. available for early career and established colleagues to hold a workshop at which colleagues can discuss drafts of their next monograph.
