The role

Applications are invited for a two-year, fixed-term Teaching Fellowship in Early Modern European and Global History, tenable from 1 September 2026. This will be a teaching-only position, across undergraduate and taught postgraduate cohorts, with no requirement that the postholder will undertake research during their appointment. The purpose of post is specifically to provide a time-limited period of teaching development and support, so as a result there is no expectation that the post will be extended beyond the advertised period of two years.

The person appointed to the position will be expected to give high-quality tutorials, classes, lectures, and supervision in History at both undergraduate and graduate level and contribute to, develop and enhance the learning and teaching in the field of Early Modern History in a situation where a significant number of early modern Faculty postholders will be on research leave or will have reduced teaching hours over the next two years, and where the Faculty wishes to enhance the existing provision of early modern courses. The applicant may have a research background in any aspect of Early Modern History, but will be expected to demonstrate that their knowledge and skills would enable them to offer credible support for some/all of the courses specified below. There is no expectation that the holder of this post



will develop new undergraduate or graduate courses during this two-year appointment, though there will be every encouragement to think creatively about the content and delivery of the existing courses, and to develop where appropriate innovative and distinctive approaches to the teaching requirements.

The appointee will be assigned a mentor, who will be a senior member of the History Faculty.

Responsibilities/duties

General duties

1. Engage positively and proactively with the academic community in the Faculty;
2. Engage in outreach activities for the Faculty of History;
3. First contact for student matters relating to attendance, conduct, coursework, performance, and welfare (referring matters to appropriate others).

Teaching, supervision and course administration

4. Lecture, tutor, and supervise undergraduate and postgraduate students for the papers listed below:

It is essential to be able to teach the second-year history course: European and World History (EWF) 7, "Eurasian Empires, 1450-1800".

We would also like, in rough order of preference, teaching support for at least two of the following:

- Preliminary Option: "Nature and Art in the Renaissance";
 - Final Honour School Theme Paper: "Global Networks of Innovation";
 - Masters Graduate Option: "Microhistory and its Uses". (This was not running in 2025-26, but the Faculty would like to offer the course over the next couple of years, and the Teaching Fellow would, in the absence of Professor Ghobrial, take charge of the course;
 - Masters Graduate Course: providing some contextual classes for the "History of War Historical Methods"; course as it will be introduced in 2026-27. The candidate would work with Professor Peter Wilson to provide the eight themed classes for this course taken by all the History of War Masters students.
5. Produce lectures, course materials and reading lists;
 6. Supervise undergraduate and Masters theses in appropriate subject areas;
 7. Mark undergraduate and graduate essays and papers and take part in University examining for undergraduates and graduates;
 8. Participate in the graduate student admissions processes, including pre-sifting applications where applicable;
 9. Gather and analyse feedback from students, colleagues, and examiners, and modify course design, content, or delivery as appropriate in discussions with the course convenors.

Faculty of History

The Faculty of History in Oxford is the largest in the UK, and one of the largest in the world. It has a very strong international reputation for its scholarship and its teaching of undergraduate and graduate students, with particular strengths that reach from late Roman times to the contemporary world, in the history of the British Isles, the history

of continental Europe, imperial and global history, the history of the United States, economic and social history, intellectual history, and the history of science, medicine, and technology. Within the Faculty there is also a department for the History of Art. With the size of its History Faculty, its lively and varied research seminars and the major resources for research, which include, among others, the outstanding collections of the Bodleian Library and the University museums, Oxford offers a uniquely attractive research environment.

Since September 2025, the Faculty has been based at the Schwarzman Centre for the Humanities, a state-of-the-art cultural centre, which is the location of seven of the constituent units of the Humanities Division.

The Faculty of History provides a robust and supportive framework for research, including:

- Financial support for research travel, research assistance, and editorial help;
- A standard sabbatical leave system, with the possibility of additional special leave;

The Faculty enables all its postholders to request up to £800 per year for research expenses, and makes additional funds available for organising conferences in Oxford. Annual career conversations identify those staff who may need extra support in achieving their research objectives, e.g. through relief from teaching or administrative burdens. Postholders can apply for seed-corn funding for specific research projects from the University's John Fell Fund, which can then help applicants to secure major external funding. In addition, to assist newly-appointed postholders in the development and publication of their research, Faculty funds are available for each new postholder to hold a workshop at which colleagues can discuss drafts of their monograph in gestation.

The Faculty has recently successfully received renewal of its Athena SWAN bronze award (first awarded in 2019), and we seek to provide a fully equal, inclusive and diverse environment for staff and students alike. There are working groups on gender equality, race equality and equality for people with disabilities, and an Equality and Diversity Committee which considers and implements policy. The Faculty has measured its performance against the recommendations of recent Royal Historical Society reports on gender and race equality and we regularly and actively implement policy to address inequalities.
